MEETING OF COUNCIL

May 8, 2023

Mayor O'Callaghan called the City of Union council meeting to order on Monday, May 8, 2023 at 7:30 p.m.

Attendance was taken and the following council members were present, Mayor O'Callaghan, Mr. Bruns, Mr. Bennett, Mrs. Thomas-Roth, Mr. Prunier and Mr. Niemann.

Other City staff members attending the meeting were John Applegate, City Manager, and Joe Moore, Law Director.

Mayor O'Callaghan called for a moment of silence.

1. Mayor O'Callaghan asked if there were any additions, deletions or corrections to the minutes of the April 10, 2023 council meeting.

Mr. Brun said there is a correction on the Agenda and moved that the Agenda be amended to show the minutes of April 10, 2023 not April 24, 2023. Mayor O'Callaghan seconded the motion. All concurred and the date for the minutes on the Agenda was amended.


4. Adjourn
