DAYTON LOGISTICS WEST L.P., A DELAWARE LIMITED PARTNERSHIP, (the "*Developer*"), AND THE MONTGOMERY COUNTY TRANSPORTATION DISTRICT (the "*District*") UNDER THE FOLLOWING CIRCUMSTANCES:

Mr. Applegate said this resolution deals with Project Pantattoni which they refer to as the "Deal property". They will have the closing this week on Wednesday, and will be building a spec building with 650,000 square feet. This document lays out the agreement and what is expected by all parties.

Mr. Bruns moved that Resolution 21-09 be adopted on the first reading. Mrs. Thomas-Roth seconded the motion. All concurred and Resolution 21-09 was passed.

4. <u>ONE READING</u> — RESOLUTION 21-10 - A RESOLUTION AUTHORIZING AND DIRECTING THE CITY MANAGER TO ENTER INTO A CONTRACT (**THIS PROJECT BOLT DAYTON LLC**) BY AND BETWEEN THE CITY OF UNION, OHIO, (the "*City*"), PURE DEVELOPMENT, INC., AN INDIANA CORPORATION (the "*Developer*") AND PROJECT BOLT DAYTON, LLC, A DELAWARE LIMITED LIABILITY COMPANY, (the "*Lessor*"), AND THE MONTGOMERY COUNTY TRANSPORTATION DISTRICT (the "*District*") UNDER THE FOLLOWING CIRCUMSTANCES:

Mayor O'Callaghan said this Resolution looks like a repeat of the one they just passed. Mr. Applegate said it is the same but this is with Project Bolt, which is the Amazon facility. He said he was sorry but they did not yet have all of the Exhibits that would go with this agreement. He said they had the Pantattoni one on the agenda because of the closing this Wednesday but this agreement came in late on Friday after the council packets had been prepared so they had not been sent the exhibits. Mr. Applegate said that he and Mr. Moore will have to look over those but once they get them, they will make sure that the council receives copies of what was sent.

Mr. Bruns moved to have one reading and adopt Resolution 21-10. Mrs. Oberer seconded the motion. All concurred and Resolution 21-10 was adopted.

5. Mayor O'Callaghan moved that the city council recess for an executive session regarding legal matters. Mr. Bruns seconded the motion. All concurred and the motion was passed and the council went into an executive session. The Mayor said there would not be any action taken after the executive session.
