Spirit of Union winner loves her old schoolhouse home

Not many people can say they live in a home that's more than 150 years old ... let alone a home that was once the first brick schoolhouse in the Village of Union. Ann Marie Shafner and Tom Tiley can claim this distinction. Right around 1860, the structure was built just east of Main Street on the north side of Martindale Road. For years, this was where the young people of Union received their first formal schooling.

Residents to receive new recycling toters in August

During the first week of August, Rumpke will deliver new 65-gallon recycling toters that can hold three times as much material as the red bins. The new toters are easily wheeled to and from the curb and have a lid to prevent litter. The toters are provided at no additional charge to residents.

Rumpke will collect the red Rumpke Recycling bins July 31. All residents will receive a green toter between Aug. 1-3. After Aug. 1, the green toters will be the only recycling container Rumpke will collect. Residents using the original circular red City of Union recycling cans may keep them but not use them for recycling with Rumpke.

Residents should follow these simple steps for using the green toter:

- Face the toter toward the street (wheels away from the street).
- Position the toter within two feet of the curb (between the curb and sidewalk when possible or behind the sidewalk if there is no grass area between the curb and sidewalk). Toters should not block the sidewalks.
- · Avoid placing the toter near a parked car, mailbox or trash receptacle. Keep a 4-foot distance between the toter and other objects.

Union was one of the first cities in the Miami Valley to start a curbside recycling program 20 years ago. With the new toters, Union should increase recycling even more than the 327 tons recycled in 2011. As of May of this year, Union residents recycled 137 tons.

Recycling is collected Tuesdays in Union and processed at Rumpke Recycling in Dayton. You can learn more about the recycling process at www.rumpkecleanandgreen.com.

What to recycle

These items are acceptable for recycling. You do not have remove labels or separate materials.

- Plastic bottles and jugs
- Aluminum and metal cans
- Cereal and snack food boxes
- · Cardboard (flattened to 2' by 3')
- · Newspaper with inserts
- · Junk mail and phone books
- Empty aerosol cans (tips removed)
- · Glass jars and bottles
- Magazines and catalogs
- · Office and computer paper
- · Cartons (juice, milk, egg substitute containers)
- · Clean pizza boxes (free of food and grease)

Why recycle

On average, each person in the U.S. produces about four pounds of trash every day. Recycling is the easiest thing you can do to reduce your impact on the Earth. Not only does recycling conserve landfill space and natural resources, it also creates jobs and saves energy.

Storage of trash cans - reminder

Just a friendly reminder about the City of Union's "trash can code." All solid wastes, while awaiting collection, must be stored in such a manner that they do not constitute a fire, health or safety hazard or provide food or harborage for vectors, and shall be contained or bundled so as not to result in spillage.

Please take out trash cans no sooner than 12 hours before trash pickup and take them in no later than 12

hours after trash pickup. When removed from the curb, please store cans either in the garage, behind the house or at the sides of the house if they are screened by a fence and not visible from the street. We appreciate your cooperation!

Union's combined water/sewer rates are the lowest in the Miami Valley!

The City of Union's combined water and sewer rates are the lowest in the Miami Valley region three years in row, according to an annual survey conducted by the City of Oakwood. Union's rates have remained low over the past seven years.

Car care and storm water pollution

What does storm water pollution have to do with owning a car? These topics may seem unrelated. But they aren't.

Whenever your car leaks oil or gasoline on the ground, there is the likelihood that these substances will be washed into storm drains during rainfall (or snow melts). Once on the streets, the oil, gasoline or other auto fluids are carried in the water to rivers and eventually to oceans where they pose threats to fish and other marine life.

Compared to the BP oil spill in the Gulf last year, this may not seem all that important, but as one of 300 million people owning cars, you can see how oil drippage and gasoline spills could seriously add up. And, the impact locally on our creeks and rivers will be even more immediate right here in our own back yard!

Vehicle owners can minimize polluting of the creeks and drains that handle storm water by doing these things:

1. When you pull up at a gas station to fill your vehicle, be careful not to spill gasoline on the pavement. Ensure that when you lift the nozzle, there is no

residual fuel that will spill. If there is some fuel there, pour it into the gas tank carefully.

- 2. Insert the nozzle carefully and deeply into the gas tank before starting the gas pump. If you intend to fill your tank, watch the tank as it fills up to avoid any overflow. Then, when you finish filling the car, take care to shake your nozzle off (into your tank) before you return it to the pump. Withdraw the nozzle slowly and carefully. Wait for the last drop to drain into the gas tank before you remove and replace the nozzle on the pump.
- 3. When parked on clean pavement, check to see that oil, brake fluid or gasoline does not leak or drip from your car. If you notice a leak, take steps to fix it quickly.
- 4. Repair leaks and dispose of used auto fluids and batteries at designated drop-off or recycling locations. Never throw used auto fluids into storm drains, catch basins or open ditches. The City of Union provides for free disposal of such automobile oils and fluids at the City Service Yard, 216 Shaw Road in Union. The drop off box is located outside the fence by the gate and your


used oil can be dropped off any time of the day.

5. Wash your car on your lawn instead of on a driveway or the street to keep the soapy wash water from washing into the storm water drains (and then on to the creeks and rivers and beyond).

Better yet, if you can afford it, wash the car at a commercial car wash that treats or recycles its wastewater. Many do. Even the ones that do not recycle drain their dirty water to the local wastewater plant where it is cleaned up before it goes into the river.

Ongoing and upcoming community accessibility improvements

The City of Union began replacing walkways in Concord Farms North last year, installing more than 3,100 lineal feet of 5-foot-wide walks. The City plans to continue this program in 2012. The walks in Concord Farms North will be completed this year, and we will begin the replacement of walkways in the Concord Farms West greenspace area. These improvements will be completed in 2013-2014. A federal Community Development Block Grant

(CDBG) for \$68,000 was awarded to the City to continue our efforts to improve accessibility. A local contractor will be replacing curb access ramps in Concord Farms North and West later this summer. Phase one of these improvements were completed in 2011 in the Beery Boulevard and Greencliff areas south of Martindale Road with the help of a \$55,000 CDBG grant. The City has submitted for a CDBG grant to install sidewalks in Community Park, which would make the facility handicapped-accessible and allow

for the walkway from Martindale Road to be extended through the park property all the way to Phillipsburg-Union Road. If the grant application is approved, this project will take place in 2013. Income tax dollars and grant funding are allowing the City to make important community improvements.

City of Union passes a "Do-Not-Solicit" ordinance

On July 9, Union City Council approved a "Do-Not-Solicit" ordinance. This ordinance will enable residents to sign up to "opt out" of having solicitors/peddlers come to your home. You can sign up any time and your address will be added to the list. Every five years, a new registration list will be created, and everyone will have to reconfirm that they want to be on the list. Once a person is signed up, your address will remain on the Do-Not-Solicit list until the next time a new registration list is created (which is every five years) but you always have the option to withdraw or add your address at any time.
